

Purpose: Use this guide to properly completing the PA Exemption Certificate (REV-1220). **NOTE: This** form may be used in conjunction with your sales tax/wholesaler license to claim exemptions from sales tax for the purpose of resale.

Step 1: Select the type of tax for which you are claiming an exemption, e.g., to claim a resale exemption for sales tax you would select *State and Local Sales and Use Tax*.



Step 2: Indicate whether the certificate will be used for a unit exemption (valid for only one transaction) or for a blanket exemption (valid for current and future transactions).

Step 4: Select the type of exemption you wish to claim and input any required account numbers or information. You should only select one type of exemption, e.g., to claim an exemption for resale you would mark box 3 and input your 8-digit sales tax license/wholesaler certificate ID number. Use the instructions with the <u>form</u> to help with inputting the correct information for the applicable exemption.

Step 6: Provide the completed certificate to the seller. The seller should accept a properly completed exemption certificate in good faith. **NOTE**: **The certificate is not sent to the State.**

RETENTION:

The seller or lessor must retain this certificate for at least four years from the date of the exempt sale to which the certificate applies.
